# **Our Mission**

Our mission is to treat, empower and support our community toward an improved quality of life. Substance use disorders are progressive, fatal illnesses that require several treatment strategies for successful recovery. We work tirelessly to eliminate barriers of economic status, race, age, gender, and physical abilities so we can deliver excellence of care to anyone in need.


We offer inpatient treatment, Medically-Assisted Treatment, Intensive Outpatient Programs for substance use and behavioral health, Office Based Opiate Treatment, adult counseling and psychiatric care, gender-specific trauma informed care, recovery housing, peer-support, childcare, and coordinated wrap-around support with Summit County agencies. These services are provided to over 1100 patients each month, and 85% of the population we serve reside in the City of Akron.

We are committed to the community of Akron, Ohio. We know that addiction impacts not just the individual, but families, communities, and economies. Treating substance use disorders can change the direction of communities by helping individuals get back to work, increase education levels, and ease strain on hospitals and social safety nets. As part of that commitment, CHC hires from the recovery community. We have employees at all levels of the organization that prove that recovery is possible, and that people in recovery can be active members of the community and workforce.

# Key Highlights for FY2023

CHC appears in the top five in multiple "best of" rankings for the state of Ohio, including Newsweek (2021-2023), Insights Care (2023), and Addiction.com (2021-2023).

This year alone, CHC saw over 5400 patients and performed over 32,000 services.



# **CHC Program Highlights**

### Serving over 5400 patients per year

**Medication Assisted Treatment (MAT)** CHC operates the most longstanding opiate treatment program in Summit County. Methadone is well known to be the most effective treatment for opiate addiction and is part of a daily routine for patients. We currently serve about 500 patients per month in the MAT program.

**Residential** CHC provides 24 residential treatment beds for men at RAMAR (Rocco Antenucci Memorial Adult Residential Center). Patients receive support during every stage of recovery in an inpatient environment and graduate into aftercare and other outpatient programming. RAMAR has served the community since 1983. This program is nearly always full.

**Women's Recovery Program (WRP)** As one of the agency's most successful programs, the Women's Recovery Program strives to addresses barriers women face through trauma-informed care, peer support groups, drop-in child care, and transportation assistance. Focus includes treatment for women on MAT or Intensive Outpatient programs, addicted pregnant women and post-partum mothers.

**Touchstone** An intensive outpatient program with supportive housing that allow two children up to age five while women are in the program. This program provides wraparound behavioral health services.

**Outpatient Counseling** CHC offers several levels of care for those patients in need of outpatient treatment. Programs serve adolescents and adults, and include Intensive Outpatient Programs (IOP), which is up to 10 hours of counseling per week, individual counseling, group counseling, and much more. Counseling services are critical to patients treated in MAT programs, which is a component often overlooked by other MAT providers in the county.

**Supportive Housing** CHC and our housing division, OMCDC, own and operate 160 units of supportive housing in NE Ohio. Programs range from permanent supportive housing to recovery housing. CHC/OMCDC is an Ohio Recovery Housing certified and ADM funded recovery housing provider. Not only does our housing program address homelessness in Summit County, it also offers individuals in early recovery from substance abuse an opportunity to seek employment and/or stable income while participating in or completing treatment. We are an equal housing agency and currently provide housing for all, from women with children, minority, underserved, aging, to disabled populations and more.

**Prevention** CHC provides prevention services to many Summit County schools through Youth-2-Youth programs. Certified prevention specialists work with school staff to provide age-appropriate prevention for students K-12. The capstone of the program is our camp experiences for middle schoolers, which builds self-esteem and develops good decision making and positive peer support skills. <u>S</u>ummit County Youth to Youth is on track to reach over 1,000 students age 5-18 this year, with positive feedback score in the 98th percentile.

# **CHC** Initiatives



### **Reducing Stigma**

CHC has always been at the forefront of care standards, education, and lobbying on behalf of those affected by substance use disorders. One key component of that is not only treatment methods and environment standards, but also community education.

As such, CHC has been participant in the Governor's stigma-reduction initiatives for the last 3 years. Through that initiative, we performed outreach to minority communities, redesigned our mission, materials, social media, and forthcoming website to fit therapeutic and person-first language standards.

We recognize that more efforts toward breaking the shame cycle that often accompanies addiction is a critical step toward encouraging earlier interventions. In 2024, we will be launching campaigns focused on the issue of stigma and how it impacts the recovery journey.

### **Gambling Addiction Prevention and Treatment**

CHC is a proud partner of the Problem Gambling Network of Ohio. Through a multi-year grant, CHC has been able to train staff members in gambling addiction treatment as a co-morbidity of substance use disorder.

Our prevention team, Summit Youth-2-Youth has incorporated underage gambling into their curriculum.

Additionally, CHC worked with Audacy streaming radio to create public service announcements for problem gambling. We chose to focus on the highest demographic population and the most overlooked: sports bettors and seniors often driven by loneliness and habit to spend on casino trips, bingo, and instant games.

In our first series, we created two PSAs: Sports betting (age 18-100, primarily male) targeted to bettors in that category Senior betting (age 65+) targeted to the families of seniors

We are also a partner with the National Council on Problem Gambling's "Gift Responsibly" campaign.

### One Vision, One Campus

### Meeting Clients Where They Are (2025)

A long-term goal of CHC is to center our services so that patients have access to all the help that they need within walking distance. Most of our clients come from the 44305 postal code, which comprises Middlebury, Arlington, and Goodyear Heights. The Middlebury neighborhood, which has hosted us for 39 years is a medicaid/ medicare reliant community that depends upon our services.

We currently house our Women's Recovery Program, our Laboratory Services, and our Outpatient/ MAT Services at 702, 719, and 725 East Market Street, respectively.

We are one step closer to this vision, however, through the purchase of 745 East Market Street. This acquisition gives CHC four buildings within 1,000 feet of each other near the corner of Buchtel and East Market, with easy access to bus routes. The proposal for 745 is multifaceted, incorporating therapeutic, administrative, and public spaces to better serve our patients, the city of Akron, and Summit County as a whole.



### Future Locations-E. Mkt. Street

This consolidation will create eight additional beds in Touchstone, three clinical spaces in Women's Recovery, and a dozen spaces for clinical patients in 725. This will increase the number of patients CHC could service by over 800 per year.

### 2023 Updates

#### Peachtree

OMCDC successfully renewed and consolidated our HUD Continuum of Care grants for Peachtree I and Peachtree II. This consolidated project is now referred to as Peachtree Estates. Peachtree Estates provides housing and supportive services for 14 previously homeless families with minor children. We were also able to purchase new playground equipment for the project--chosen, in part, by the children who live there.

#### **Recovery Housing**

OMCDC currently owns/operates six recovery housing properties; 5 for males and 1 for females and/or females with infants.

#### "Health Home" Expansion 2024

Since 2019 we have been partnering with United



Healthcare to provide housing and supportive services to homeless United Healthcare members. Due to their homelessness, they unnecessarily spend months and sometimes years in nursing homes and rehab centers. Through this collaborative partnership, OMCDC has been providing housing and case management services. United Healthcare has provided care coordination, on-site medical services and transportation. This provision of housing and intensive services has enabled these individuals to live stably in their own home and substantially reduced emergency room visits as well as hospital and nursing home admissions.

Due to the success of the "Health Home" program model and our years of experience with operating this type of program, we were approached by the Summit County Continuum of Care and allowed to apply for funding for a new project. In early 2023 we were informed that our "New Genesis Health Home project" had been funded. In addition to the continuum of Care funding, we were awarded a \$75,000 grant from Anthem to expand this new project. The New Genesis project is off to a great start. We have secured a beautiful 7 bedroom home for this project, and are currently in the process of furnishing and preparing the new home for occupancy. We expect to welcome our first resident in February of 2024!
