

After nearly 34 years as the chief executive officer, Ted bid farewell to CHC, an agency he built into one of the most comprehensive and innovative healthcare facilities in Northeast Ohio.

Community Health Center will celebrate its 40th anniversary in 2014, just as I complete my first year as CEO. In the words of Ted Ziegler, as expressed in the 1980 annual report (his first year as CEO), I echo his sentiment, "Without a staff of hardworking, committed and supportive people who have the courage and determination to face unknown territory, constantly seeking new solutions, and an uncompromising commitment to serve in our community, this year's services would not have been possible."

On behalf of our patients, staff and Board of Directors, I thank you for your continued support of Community Health Center and I look forward to working with you in the coming years to provide comprehensive substance abuse treatment to meet the needs of our patients and the greater community.

TREATMENT SERVICES

Our MAT program is
constantly at capacity, with
a census of over 400 at any given
time. At the end of 2013, CHC developed
a new program – Fresh Start, funded by
the Summit County ADM Board to fast track
patients directly from ADM Crisis Center into a
six-month MAT treatment program where intense
residential treatment is used in conjunction with
suboxone therapy and intensive outpatient
programming. Twenty-five patients will
be served in the first year of this
pilot program.



MEET KATHY PERGE

Division Director—Intake/Diagnostic and Special Programming Years At CHC: 33

Working at CHC gives me a sense of higher purpose. We all are just humans with strengths, weaknesses, frailties, promises and dreams. When you look in our patients' eyes you see people who want the same things we do.

Some of my fondest memories are of us going through our first JCAHO survey in 1984. We worked non-stop for a year, then worked day and night the week leading up to it and literally all night during the survey—and we made it!

ASSESSING THE NEED

Our Diagnostic Department is the first step in treatment for new patients at CHC. It begins with an in-depth assessment where the chemical dependency and mental health problems are identified as well as other areas of concern including criminal involvement, family issues and education/vocation deficiencies. A treatment plan is designed with all the needs of the patient in mind. Our treatment staff assists our patients through the recovery process, which can last as little as 90 days to several years.

MEDICATION-ASSISTED TREATMENT (MAT) FOR OPIATE ADDICTION

One of only 15 regional methadone clinics in Ohio offering methadone maintenance and detoxification treatment for opiate addiction. Methadone has been identified as the single most effective treatment for opiate addicts and is part of a daily routine for patients. CHC also offers suboxone as a treatment option for patients through our two medical offices.

RESIDENTIAL TREATMENT

At RAMAR (Rocco Antenucci Memorial Adult Residential Center) patients receive support during every stage of recovery in an inpatient environment. The 28-bed facility provides services for men and women and sees about 225 patients annually. Treatment includes group and individual counseling and development of recovery skills. Women who deliver babies while in treatment may be eligible to move to Genesis – an on-site group home for women with infants. This enables our patients to continue treatment while adjusting to motherhood in a supportive environment.

MEET JACKIE KAUTENBERGER

CHC has become my second home, and I have a great family with whom I work. We save lives everyday, though we are not aware of it—by providing substance abuse counseling, we are preventing people from overdosing or driving impaired. The best part of my job is when I see someone succeed in their recovery, such as the time a man walked in and thanked me after he earned his 10-year coin in NA, saying I referred him to the 12 steps all those years ago.



2013 STATS

In 2013, **576** women were treated in WRP including 76 pregnant women; more than 80% were opiate addicted.

42 drug-free babies were born to mothers in recovery.

WOMEN'S RECOVERY PROGRAM

This program strives to remove barriers for women who are struggling with an alcohol or chemical dependency addiction. These barriers are removed through trauma-informed care, peer support groups, drop-in child care, parenting training and transportation assistance. Focus includes treatment for women on methadone or IOP, addicted pregnant women and post-partum mothers.

INTENSIVE OUTPATIENT PROGRAM

Provides a therapeutic multi-disciplinary program designed to promote the recovery process through three levels of treatment including group and individual counseling, case management, vocational development, community support groups and reintegration programming.

ADULT COUNSELING

Includes weekly individual counseling and referrals to a wide array of chemical dependency and specialty groups providing education, peer support and accountability which have been proven to aid patients in the recovery process. Medical and housing assistance services may also be provided.



MEET JAN WAGNER Chief Operating Officer Years at CHC: 36

Working at CHC has been an incredible journey. To be part of a team that grew the agency from a budget of \$500,000 to \$11 Million annually , has been an exciting adventure! I have so many great memories, but it comes down to working together to resolve problems... and of course lots and lots of good times.

Being able to provide the right service, at the right time, to our patients is what it is all about. To work with individuals who have lost hope and feel a sense of worthlessness and to help them achieve goals and sobriety is amazing – you are witness to human transformation that, sometimes, you don't even think can happen, although you always hoped it would.

DIRECT THERAPY

Still one of the most cutting-edge programs in treatment today, our video therapy program provides treatment online for mental health and substance abuse disorders via video conferencing. DirectTherapy is the primary treatment method for women living at Touchstone Supportive Housing and has proven to be a successful way to engage in the treatment process. We have also partnered with the Ohio Bar Association to offer this service to professionals seeking treatment.

MENTAL HEALTH SERVICES

CHC offers mental health services to those adult patients who have Medicaid or who are currently enrolled in services for chemical dependency. Our qualified staff provide one-on-one counseling and group sessions for most primary mental health disorders including post partum depression, bipolar disorder, depression, stress management and much more.

ADOLESCENT TREATMENT PROGRAM

Our focus continues to be on the teenage patients' needs, therefore we offer an Adolescent Intensive Outpatient Program (IOP). This structured 3-4 day per week program, which is held after school (with a meal), provides greater accountability and therapeutic contact with the youth and their families. In addition, there are many other options for patients including individual counseling for addiction and/or mental health, specialized groups, a weekly young people's AA and much more. The program sees patients ages 13-21.

Community Health Center strives to be diverse in our program offerings, that's why we offer treatment programs beyond the traditional social service agency. Programs like these below help further the recovery of our patients in treatment but they also strive to enhance the health of the general public.

COMMUNITY HEALTH CENTER MEDICAL CENTER & LASER SERVICES

The location is also home to our medical department, serving the general public. Services include: internal medicine, Suboxone treatment, outpatient surgical procedures and cosmetic laser services all in one office. Our cosmetic laser is perfect for patients who are looking to remove tattoos, age & sun spots, wrinkles, birthmarks and unwanted hair. Laser treatment is a safe, non-invasive way to address cosmetic needs without visiting a dermatologist or plastic surgeon.



EAP & DRUG FREE WORKPLACE PROGRAM

Our Employee Assistance Program focuses on helping companies develop policies and procedures to decrease workplace accidents and workers' compensation claims. We provide licensed DOT physicals, on-demand drug testing, on-site trainings and annual flu shot clinics.

In 2013 our EAP program served 201 companies.

LABORATORY SERVICES

Thousands of patients come in our doors every year for one reason only – for a drug test. CHC holds contracts with many local service providers and companies for urine drug screen (UDS) services. CHC provides state-of-the-art services at our main location to provide comprehensive screening as well as other medical laboratory tests.

WRAP-AROUND SERVICES

The outreach programs at Community Health Center are designed for two reasons—to prevent problems, such as drug abuse, before they start or to provide after-care once recovery has been obtained. Both functions of our outreach programs serve as a safety net in the community. These programs all have a strong education component, whether for teaching teens how to say no to drugs or by showing recovering adults how to utilize the programs available to them in the community.

Project PANDA The goal of PANDA (Prevent and Neutralize Drugs and Alcohol) is to educate middle school students, not only about the dangers of drug and alcohol abuse, but also about peer pressure, decision-making and self-esteem. This goal is accomplished during a Friday through Sunday educational camp experience.

Help Me Grow Free home-visitation program that supports families of children from birth to age three. The goal is to strengthen the child's development and give them the best chance possible to achieve success by assisting with positive parenting skills and access to the community network of services. Funded by the Summit County Family & Children First Council, Help Me Grow served over 200 children in 2013.

Case Management Services Often times, our case managers are the glue that holds our patients' treatment plan together. Case managers help patients navigate the services available to them in the community, provide transportation and overall support as they are in the healing process.

Community Clubhouse for Brain Injury A community based program offering long-term support for individuals with brain injuries. The Clubhouse focuses on re-entry activities, speech and occupational therapies and much more.

HOUSING FOR INDIVIDUALS IN RECOVERY

Community Health Center in cooperation with our housing partner, Ohio Multi-County Development Corporation (OMCDC), offers housing as a part of after-care for individuals in recovery. Our housing programs continue to be a successful component of treatment and illustrate the fact that safe, secure and sober housing improves the likelihood of successful outcomes.

Touchstone Supportive Housing Program

Transitional housing for single women while they continue treatment. Women with children, who are pregnant or disabled, are eligible for residency.




